## 2010 Fees Schedule

ICBR's two REALTOR® membership categories are Primary and Secondary. The only difference between the two categories is that as a Primary REALTOR® member, ICBR collects and pays your Indiana Association of REALTOR® and National Association of REALTOR® dues. Dues are prorated based on the month your application is approved.

All applications are approved by the Board of Directors at monthly meetings. **See below for application deadlines.
